## BULGARIA

I. Residence permits for third-country nationals are issued in accordance with Council Regulation (EC) № 1030/2002 of 13 June 2002 laying down a uniform format for residence permits for third-country nationals and Council Regulation (EC) № 380/2008 of 18 April 2008 amending Regulation (EC) № 1030/2002:

1. Residence permit for a prolonged residence in the Republic of Bulgaria foreigner – type of permit „Prolonged residence“ issued by the authorities of the Ministry of Interior with a validity period of up to one year. The document is issued in accordance with the provisions of the Foreigners in the Republic of Bulgaria Act.

2. Residence permit for a long-term resident-EU – type of permit „Long-term resident-EU“ issued by the authorities of the Ministry of Interior with a validity period of 5 years.

3. Residence permit for a foreigner permanently residing in the Republic of Bulgaria – type of permit „Residence permit“, issued by the authorities of the Ministry of Interior for a period depending on the validity of the national identity document with which the person has entered the Republic of Bulgaria, but for no more than 5 years.

4. Residence permit type „EU Blue Card“ – issued by the authorities of the Ministry of Interior with a period of validity of up to 5 years according to the requirements of Regulation (EC) No 1030/2002, as the field „permit type“ is replaced by „EU Blue Card“ and in the field „note“ is noted the relevant remark in accordance with the provisions of the Foreigners in the Republic of Bulgaria Act, where applicable. The document is issued on the basis of the Foreigners in the Republic of Bulgaria Act.

5. Residence permit type „EU Blue Card“ – issued by the authorities of the Ministry of Interior with a period of validity of up to 5 years according to the requirements of Regulation (EC) No 1030/2002, as the field „permit type“ is replaced by „EU Blue Card“ and in the field „note“ is noted: “International protection granted by the Republic of Bulgaria on...(date)”. The document is issued on the basis of the Foreigners in the Republic of Bulgaria Act.

6. Single residence and work permit – type of permit „Single permit“ issued by the authorities of the Ministry of Interior with a validity period of up to three years in accordance with the requirements of Regulation (EC) No 1030/2002, the field „type of permit“ is replaced by „single permit“ and in the field „note“ the condition for access to the labor market is indicated. The document is issued on the basis of the Foreigners in the Republic of Bulgaria Act.

7. Seasonal worker permit – type of permit „Seasonal worker“ issued by the authorities of the Ministry of Interior in accordance with the requirements of Regulation (EC) No 1030/2002, as in the field „type of permit“ shall be marked „seasonal worker“ and in the field „note“ the condition for access to the labor market is indicated. The document is issued on the basis of the Foreigners in the Republic of Bulgaria Act.

8. Permit for a person moved in intra-corporate transfer – issued by the authorities of the Ministry of Interior in accordance with the requirements of Regulation (EC) No 1030/2002, as in the field „type of permit“ is marked „ICT - intra-corporate transfer“ and in the field „note“ the condition for access to the labor market is indicated. The document is issued on the basis of the Foreigners in the Republic of Bulgaria Act.

9. Residence permit for a long-term resident type of permit „Prolonged residence“ with the indication „beneficiary according to Article 3(2) of Directive 2004/38/EC“ – issued by the authorities of the Ministry of Interior with a validity period of up to 5 years.

10. Residence permit of a permanent resident type „Residence permit“ with the indication „beneficiary pursuant to Article 3(2) of Directive 2004/38/EC“ – issued by the authorities of the Ministry of Interior with a validity period of up to 10 years.

11. Mobility permit for intra-corporate transfer – issued by the authorities of the Ministry of Interior in accordance with the requirements of Regulation (EC) No 1030/2002, as in the field „permit

type“ is marked „mobile ICT – mobility at ICT“ and in the field „note“ the condition for access to the labor market is indicated

12. Prolonged residence permit of a foreigner type of permit „Prolonged residence“ marked „researcher“ – issued by the authorities of the Ministry of Interior with a validity period of up to one year.

13. Residence permit for a foreigner who is long-term resident in the EU – issued by the authorities of the Ministry of Interior with a validity period of 5 years; in the residence permit of a foreigner who has long-term resident in the EU who has resided as an EU Blue Card holder, in the field „note“ is marked „former EU Blue Card holder“.

14. The residence permit of a long-term resident in the EU foreigner on the grounds of granted international protection by the Republic of Bulgaria in the field "note" shall be noted: "International protection granted by the Republic of Bulgaria on ..... (date)"

15. Residence permit for a prolonged term residence of a national of United Kingdom of Great Britain and Northern Ireland or of a member of his family as required by Regulation (EC) № 1030/2002, with the entry in the field „type of permit“ – „Art. 50 TEU“ and in the field „note“ is marked „Art. 18 (4) of the Agreement“ – issued by authorities of the Ministry of Interior with a validity period up to 5 years.

16. Permanent residence permit of a national of the United Kingdom of Great Britain and Northern Ireland or of a member of his family, as required by Regulation (EC) No 1030/2002, with the entry in the field „Type of permit“ with the entry „Art. 50 TEU Residence permit“ and in the field „Note“ is marked „Art. 18 (4) of the Agreement“ – issued by the bodies of the Ministry of Interior with a period of validity of 10 years.

17. Residence permit for a prolonged term resident family member of a Bulgarian citizen with the indication of „family member of a Bulgarian citizen“ – issued by the authorities of the Ministry of Interior with a validity period of up to one year; The document is issued to persons who have obtained the right of continuous residence on the grounds of art. 24, para. 1, item 18 of the Foreigners in the Republic of Bulgaria Act.

18. Residence permit for a prolonged term resident in the Republic of Bulgaria foreigner marked „unaccompanied child foreigner“ – issued by the authorities of the Ministry of Interior with a validity period of up to one year.

19. Residence permit for a permanent resident family member of a Bulgarian citizen with the indication of „family member of a Bulgarian citizen“ – issued by the authorities of the Ministry of Interior for a period depending on the validity of the national identity document with which the person has entered the Republic of Bulgaria, but for no more than 5 years; The document is issued to persons who have received the right of permanent residence on the grounds of art. 25, para. 1, item 11 of the Foreigners in the Republic of Bulgaria Act.

20. Prolonged term residence permit of a foreigner marked „researcher – mobility“ – issued by the authorities by the Ministry of Interior with a validity period of up to two years.

21. Prolonged term residence permit of a foreigner marked „student“ – issued by the authorities of the Ministry of Interior with a validity period of up to one year.

22. Prolonged term residence permit of a foreigner marked „pupil“ – issued by the authorities of the Ministry of Interior with a validity period of up to one year.

23. Prolonged term residence permit of a foreigner marked „trainee“ – issued by the authorities of the Ministry of Interior with a validity period of up to one year.

24. Prolonged term residence permit of a foreigner marked „volunteer“ – issued by the authorities of the Ministry of Interior with a validity period of up to one year.

25. Residence card, as in the field „note“ is marked „family member of a EU Art. 10 Dir. 2004/38/EC – issued by authorities of the Ministry of Interior with a validity period of up to 5 years.

26. Residence card, as in the field „note“ is marked „family member of a EU Art. 20 Dir. 2004/38/EC – issued by authorities of the Ministry of Interior with a validity period of up to 10 years.

27. Residence permit of a prolonged term resident family member of an EU citizen who has not exercised his right to free movement – issued according to Regulation (EC) No 1030/2002 with a validity period of up to 5 years, as in the field „note“ is marked „family member Directive 2004/38/EC“.

28. Residence permit of a permanent resident family member of an EU citizen who has not exercised his right to free movement – issued according to Regulation (EC) No 1030/2002 with a validity period of up to 10 years, as in the field „note“ is marked „family member Directive 2004/38/EC“.

29. Diplomatic card – issued to a diplomatic employee in a diplomatic or consular representation or in an international organization accredited in the Republic of Bulgaria with a period of validity depending on the period of accreditation.

30. Consular card - issued to a consular employee in a diplomatic or consular representation or in an international organization, accredited in the Republic of Bulgaria with a period of validity depending on the period of accreditation.

31. Card of administrative and technical staff - issued to an administrative and technical employee in a diplomatic or consular representation or in an international organization accredited in the Republic of Bulgaria with a period of validity depending on the period of accreditation.

32. Card of service staff - issued to an employee of the servicing staff in a diplomatic or consular representation or in an international organization, accredited in the Republic of Bulgaria with a period of validity depending on the period of accreditation.

II. All other documents issued to third-country nationals having equivalent value to a residence permit:

1. Temporary Protection Registration Card of Foreigner with Temporary Protection: (Регистрационна карта на чужденец с предоставена временна закрила)

Temporary Protection Registration Card of Foreigner with Temporary Protection is issued to beneficiaries of temporary protection based on the legislative framework concerning the compliance with the Temporary Protection Directive and the Council implementing Decision 2022/382 of 4 March 2022. It is issued to the following categories: a) Displaced Ukrainian nationals b) stateless persons or nationals of another third-country, other than Ukraine, who left Ukraine resulting the war. The validity of Temporary Protection Registration Card of Foreigner with Temporary Protection is prolonged on the basis of Ministerial Decision no. 144/10.03.2022 on providing temporary protection for displaced persons from Ukraine, extended with the following Ministerial Decisions: no. 180 of 2022, no. 240 of 2022, no. 95 of 2023, no. 642 of 2024, no 79 of 2025, as well as all further prolongations in accordance to the Council Decisions amending Council implementing Decision 2022/382.

2. Card of subsidiary protection beneficiary

The card of subsidiary protection beneficiary in the Republic of Bulgaria is issued to third country nationals who have been granted subsidiary protection. It is issued by the authorities of the Ministry of Interior of the Republic of Bulgaria with a period of validity of up to 3 years. The card certifies the identity of the person and the right of its holder to reside on the territory of the Republic of Bulgaria for the period of its validity. It will facilitate the smooth and regulated travel of third country nationals with subsidiary protection in the Republic of Bulgaria.

3. Passport of subsidiary protection beneficiary

The passport of subsidiary protection beneficiary is issued by the authorities of the Ministry of Interior of the Republic of Bulgaria to a foreigner with subsidiary protection with a period of validity of up to 3 years but not longer than the period of validity of the Card of subsidiary protection beneficiary. The passport entitles its holder to leave and enter the Republic of Bulgaria within the period of its validity under the conditions and according to the procedure for foreigners permanently residing in the Republic of Bulgaria.

4. Card of a Refugee

The card of a refugee is issued by the authorities of the Ministry of Interior to a person with refugee status with a period of validity of 3 to 5 years and certifies the identity of the person and the right of its holder to reside on the territory of the Republic of Bulgaria for the period of its validity.

#### 5. Travel document (Convention of 28 July 1951)

This document is issued by the authorities of the Ministry of Interior to a foreigner granted refugee status with a period of validity of up to 5 years, but not longer than the period of validity of the card of a refugee, and entitles its holder to leave and enter the Republic of Bulgaria within the period of its validity under the conditions and according to the procedure for Bulgarian citizens, as long as the country to which he/she is traveling does not provide for other requirements.

## CZECH REPUBLIC

### 1) Uniform format (ID card)

Residence permits are issued in the form of an ID card made of a polycarbonate card with biometric features following to a uniform model. The validity period depends on the type of stay, in accordance with Act No. 326/1999 Coll., on the Residence of Foreign Nationals in the Territory of the Czech Republic and on Amendments to Certain Acts, as well as Act No. 325/1999 Coll., the Asylum Act, as amended.

#### A) Residence Permit/ Povolení k pobytu

This document can be obtained by **third-country nationals with a long-term or permanent residence permit** in the Czech Republic, **family members of EU, Norwegian, Swiss, Icelandic, and Liechtenstein citizens** who do not meet the conditions for issuing a "*Permanent Residence Card*" / "*Karty trvalého pobytu*" or "*Residence Card*" / "*Pobytové karty*", and **persons granted asylum or subsidiary protection**.

Since 2 August 2021, the document has also been issued to **UK citizens and their family members covered by the Withdrawal Agreement**.

The "*Remarks*" / "*Poznámky*" section includes a two-digit code specifying the purpose of stay (*see table below*). For permits issued for reasons other than employment, the note "*Free access to the labour market – YES/NO*" / "*Volný přístup na trh práce – ANO/NE*" is added. The address of residence is provided only for authorisations of the type "*PERMANENT STAY*" / "*TRVALÝ POBYT*", "*ASYLUM*" / "*AZYL*", and "*SUBSIDIARY PROTECTION*" / "*DOPLŇKOVÁ OCHRANA*".

- i) **Residence Permits issued from 4 July 2011 until 26 June 2020** in the form of ID cards in accordance with Council Regulation (EC) No 380/2008 of 18 April 2008 amending Regulation (EC) No 1030/2002 laying down a uniform format for residence permits for third-country nationals. **These permits remain valid until June 2030.**

Under the heading Type of permit, the relevant type of stay is specified: *"Long-term residence"/"Dlouhodobý pobyt", "Employee card"/"Zaměstnanecká karta", "EU Blue Card"/"Modrá karta EU"* (Council Directive 2009/50/EC), *"ICT"* (Intra-Company Transfer Card under Directive 2014/66/EU), *"MOBILE ICT"* (Intra-Company Transfer Card from another EU Member State under Directive 2014/66/EU), or *"Permanent"/"Trvalý"*.

- ii) **Residence Permits issued since 27 June 2020** in the form of ID cards in accordance with Regulation (EU) 2017/1954 of the European Parliament and of the Council of 25 October 2017 amending Council Regulation (EC) No 1030/2002 laying down a uniform format for residence permits for third-country nationals.

#### B) Residence Card/ Pobytová karta

Residence Card **issued since 2 August 2021** in the form of an ID card in accordance with Regulation (EU) 2017/1954 of the European Parliament and of the Council of 25 October 2017 amending Council

Regulation (EC) No 1030/2002 laying down a uniform format for residence permits for third-country nationals. The back of the card is identical to the residence permit (*see section A above for more details*). Issued only to family members of EU citizens who are not themselves EU citizens.

C) Permanent Residence Card/ Karta trvalého pobytu

Permanent Residence Card **issued since 2 August 2021** in the form of an ID card in accordance with Regulation (EU) 2017/1954 of the European Parliament and of the Council of 25 October 2017 amending Council Regulation (EC) No 1030/2002 laying down a uniform format for residence permits for third-country nationals. The back of the card is identical to the residence permit (*see section A above for more details*). Issued only to family members of EU citizens who are not themselves EU citizens.

**2) All other documents issued to third-country nationals of equivalent value to a residence permit**

A) Residence Card of a Family Member of a Citizen of the European Union/ Pobytová karta rodinného příslušníka občana Evropské unie

A dark blue document in the form of a booklet. Document issued from 1 January 2013 until 1 August 2021 to family members of EU citizens who have been granted temporary residence in the Czech Republic. The card was **valid until 3 August 2023**, after which it was fully replaced by a document with biometric data (*see section 1 – uniform format for more details*).

B) Permanent Residence Card/ Průkaz o povolení k trvalému pobytu

- i. Permanent Residence Card is a dark green document in the form of a booklet. **Since 2 August 2021, this card has only been issued to citizens of the EU, Switzerland, Norway, Iceland, and Liechtenstein.**

Previously, this permanent residence card was also issued to family members of EU, Swiss, Norwegian, Icelandic, and Liechtenstein citizens. However, since 2 August 2021, these family members receive documents with biometric data (*see section 1 – uniform format for more details*). This also applies to UK citizens and their family members who are covered by the Withdrawal Agreement. **Documents issued before 2 August 2021 remain valid until their expiry date.**

- ii. Permanent Residence Card of a citizen of the European Union is a red document in the form of a booklet. This type of document was issued to EU citizens until August 2017. It can remain in circulation until 2027.

C) Residence Permit Card for Foreigners/ Průkaz o povolení k pobytu pro cizince

A light green document in the form of a booklet with red print on the front. Until 14 August 2017, it was issued to citizens of Switzerland, Norway, Iceland, and Liechtenstein with permanent residence in the Czech Republic, as well as their family members with temporary residence permits. Since 15 August 2017, it has been intended only for family members of citizens of these states for temporary residence. **The document expired on 3 August 2023,**

after which it was fully replaced by documents containing biometric data (*see section 1 above – uniform format*).

D) Identity Card/ Identifikační průkaz

i) Identity Card – issued since 15 August 2017.

Since 15 August 2017, an identity card has been issued with black color inscription on the front side *'Identity Card and long-term residence permit' / 'Identifikační průkaz a povolení k pobytu'*.

This document is in the form of a paper card sealed in foil, with dimensions of 105 × 74 mm. On the front side, there is a photograph of the holder along with details such as name, nationality, date of birth, gender, function, address, and the card's validity date. On the back, it is stated that this identity card serves as an official document and proof of identity, as well as proof of long-term residence in the Czech Republic.

ii) and iii) Identity Card issued to citizens of EU member states or citizens of third countries– issued since 1 December 2025.

Since 1 December 2025, identity cards are being issued with black color inscription on the front side *'Identity Card / 'Identifikační průkaz'* for citizens of EU member states and black color inscription *'Identity Card and long-term residence permit' / 'Identifikační průkaz a povolení k pobytu'* for citizens of third countries.

On the front side, there is a photograph of the holder along with details such as name, nationality, date of birth, gender, function, address and the card's validity date. On the back, it is stated that this identity card entitles the holder to reside in the Czech Republic. The back side of the document for both citizens of EU member states and citizens of third countries is identical.

**The identity cards issued since 15 August 2017 remain valid despite the issuance of new identity cards since 1 December 2025.**

The identity cards are issued by the Ministry of Foreign Affairs with the following designation:

E) Residence Documents Issued to Holders of Temporary Protection and Foreign Nationals Granted Long-Term Visas for a Stay Longer than 90 Days for the Purpose of Tolerated Stay Due to the Armed Conflict in Ukraine

Under Council Implementing Decision (EU) 2024/1836 of 25 June 2024 extending temporary protection as introduced by Implementing Decision (EU) 2022/382 of 4 March 2022 establishing the existence of a mass influx of displaced persons from Ukraine within the meaning of Article 5 of Directive 2001/55/EC and having the effect of introducing temporary protection (OJ L 71, 4.3.2022, p. 1), and § 7b of Act No. 24/2025 Coll., amending Act No. 65/2022 Coll., on certain measures in connection with the armed conflict on the territory of Ukraine caused by the invasion of the armed forces of the Russian Federation, the following system of residence documents for displaced persons from Ukraine applies in the Czech Republic.

Residence documents for temporary protection in the Czech Republic consist either of a visa sticker for residence authorisation (affixed in the passport or on a state border crossing report) or a PDF confirmation of the extension of temporary protection. Combined with a travel document, these entitle displaced persons to cross the external border of the Schengen area without a visa. Temporary protection documents (visa sticker or PDF confirmation) constitute a residence permit in accordance with Article 2(16) of the Schengen Borders Code.

### 1. Visa Stickers for Residence Authorisation (Temporary Protection)

- Holders of temporary protection who in 2025 received a long-term visa for the purpose of temporary protection have a visa sticker affixed in their passport or on a state border crossing report with validity until 31 March 2026. The validity of these visa stickers may exceed 365 days. These holders do not register for electronic extension and **do not receive a PDF confirmation**; the visa sticker is their sole and full-fledged residence and travel document within Schengen.
- Holders of temporary protection who in 2024 had a visa valid until 31 March 2025 registered electronically for extension in 2025. If they do not yet have a new visa sticker valid until 31 March 2026 affixed, they possess a visa sticker valid until 31 March 2025 **along with the PDF confirmation of electronic registration for extension of temporary protection**. This confirmation is a valid residence document until 30 September 2025.
- Holders of temporary protection who have already successfully completed the extension have a new visa sticker valid until 31 March 2026 affixed in their passport or on a state border crossing report. There is no need to prove the existence of a PDF confirmation; the visa sticker is a full-fledged document.

### 2. Confirmation of Electronic Registration for the Extension of Temporary Protection

Pursuant to § 7b of Act No. 24/2025 Coll., which amends Act No. 65/2022 Coll., it was possible to automatically extend the validity of authorisations for temporary protection without the need for a new application through electronic registration. A "Confirmation of Electronic Registration for the Extension of Temporary Protection" issued by 15 March 2025 entitles the holder to reside in the territory of the Czech Republic and to move freely within the Schengen area until 30 September 2025. The validity of this confirmation can be verified by QR code or via the website of the Ministry of the Interior of the Czech Republic: <https://ipc.gov.cz/docasna-ochrana/overeni-potvrzeni/>.

NB: Prior to 1st April 2008 the Ministry of Foreign Affairs issued unnumbered and partly handwritten pink residence permit stickers:

These stickers are still in circulation and are valid for the period indicated on the sticker.

Identity cards for diplomats, technical and administrative staff, domestic servants etcetera issued by the Ministry of Foreign Affairs are not proof of permission to reside in Denmark and do not give the holder the right to enter the territory without a visa if required.

## 2. All other documents issued to third-country nationals having equivalent value to a residence permit

NB: These permits are valid in lieu of a visa, for entry without a visa, only if issued in a passport or separately in conjunction with a passport, not if issued as an internal document in lieu of an identity card.

An "Aussetzung der Abschiebung (Duldung)" (deferral of expulsion (exceptional leave to remain)) or an "Aufenthaltsgestattung für Asylbewerber" (temporary residence permit for asylum seekers) are not valid for entry without a visa.

– Fiktionsbescheinigung

(Provisional residence document)

Only if the third box on page 3 is ticked – the residence permit continues to be valid. Entry is allowed only in connection with an expired residence permit, visa, a valid passport pursuant to Article 10 of Directive 2004/38/EC, or a German permanent residence card pursuant to Article 20 of Directive 2004/38/EC.

If the first or second box is ticked, the "Fiktionsbescheinigung" does not entail the right of entry without a visa.

Provision on the implementation of the Agreement on the withdrawal of the United Kingdom of Great Britain and Northern Ireland from the European Union and the European Atomic Energy Community

As provided for in the provisions concerning the withdrawal of the United Kingdom of Great Britain and Northern Ireland from the European Union, with effect from the end of the transition period under this Agreement, British nationals and their family members who hold rights in Germany under Part Two Title II Chapter 1 or under Article 24 (2), also in conjunction with Article 25 (2) of the Agreement, are allowed to enter even if they do not have an expired residence permit or a visa in addition to their passport also with a "Fiktionsbescheinigung" (provisional residence document) in which the fourth box on page 3 is marked, indicating (In German) that "The holder has applied for documentation of a right of residence under the Freedom of Movement Act/EU or the EU-Switzerland Agreement, which is hereby provisionally certified", even if they do not have an expired residence permit and a visa in addition to their passport. That indication in the document is written in German and reads: "Der Inhaber / die Inhaberin hat die Dokumentation eines Aufenthaltsrechts nach dem FreizügG/EU oder dem Abkommen EU-Schweiz beantragt, das hiermit vorläufig bescheinigt wird."

The same box is marked if the holder already has applied for documentation of a right of residence under the Freedom of Movement Act/EU or the EU-Switzerland Agreement, but no document according to the uniform format defined by Council Regulation (EC) No 1030/2002 is ready for issuance. In this case, the right of residence is certified by the provisional residence document. In such cases, holders of a Fiktionsbescheinigung are allowed to enter if the fourth box on page 3 of the document is marked, indicating that "The holder has applied for documentation of a right of residence under the Freedom of Movement Act/EU or the EU-Switzerland Agreement, which is hereby provisionally certified", even if they do not have an expired residence permit or a visa in addition to their passport.

– Passes for members of diplomatic missions:

NB: Since 1 August 2003 a new type of pass has been issued for members of diplomatic missions and for members of career type consular posts. Those types of passes established before 1 August 2003 are no longer valid.

The attendant privileges are shown on the back of each pass.

This document is issued to honorary consuls.

It is used for the period the WA beneficiary awaits the printing and issuance of the residence permit and is retained by the competent authority upon service and receipt of the residence permit.)

(Special Certificate of Legal Residence of No 4000/1/113-α' Joint Ministerial Decision)

This certificate is granted to UK nationals and their family members, also UK nationals, whose application for the issuance of the residence permit under article 18 par. 4 WA has been rejected and they have made an appeal against this decision. Holders of this certificate prove that they enjoy the citizens' rights of Part Two of the WA, for the period pending a final judgment handed down against any rejection of such application. It is valid for one year. This certificate is retained by the competent authority after the examination and the final judgment on the appeal.)

### 4. Residence document for holders of the right of residence under Article 18 (4) of the Withdrawal Agreement

It is noted that the validity of the Residence Permit to be issued to those who have acquired the right of permanent residence in Greece under the Withdrawal Agreement, is ten (10) years, while the validity of the Residence Permit to be issued to those who have not acquired the right of permanent residence right, is five (5) years.

#### 5. Temporary Protection Residence Permit to Temporary Protection Beneficiaries:

(Temporary Residence Permit is issued to of beneficiaries of temporary protection based on the legislative framework concerning the compliance with the Temporary Protection Directive and the Council implementing Decision 2022/382 of 4 March 2022 in compliance with art. 32 (namely Council Directive 2001/55/EC, Presidential Decree 80/2006 (G.G. A’ 82), Legal Code of Reception, International Protection and Temporary Protection. Law no 4939/2022 (G.G. A’ 111) and the Ministerial Decisions No. 31035/04.03.2022 and No. 172172/28.03.2022). It is issued to the following categories:

- a) Ukrainian nationals residing in Ukraine before 24 February 2022,
- b) stateless persons or nationals of another third-country, other than Ukraine, who legally resided in Ukraine before 24 February 2022 as beneficiaries of international protection or of equivalent national protection, and
- c) the family members of the persons referred to in the above cases. Also, according to the decision, the following persons shall be considered to be part of the family, if the family already existed and resided in Ukraine before 24 February 2022:
  - a) the spouse of a person who falls under points a) or b) or the person with whom he/she cohabits with, in a free union within the framework of a stable relationship duly proven,
  - b) the unmarried minor children of a person falling under points a) or b) or the children of his/her spouse, without distinction, as to whether they were born in or out of wedlock or if they were adopted;
  - c) other close relatives who lived together as part of the family unit at the time of the circumstances related to the mass influx and who are completely or mainly dependent on a person referred to in points a) or b) at that time.

On the basis of Ministerial Decision no. 81645/08.02.2023, concerning the extension of validity of the temporary protection status for displaced persons from Ukraine, the validity of Temporary Protection Residence Permits that expire by 4 March 2023 is automatically prolonged for an additional period of six (6) months, that is, until 4 September 2023. If during the aforementioned period the European Commission does not decide to terminate temporary protection as a residence status, the validity of Temporary Protection Residence Permits will be automatically prolonged for an additional six (6) months, that is, until 4 March 2024.

On the basis of Ministerial Decision no. 392634/20.08.2023, concerning the extension of validity of the temporary protection status for displaced persons from Ukraine, the validity of Temporary Protection Residence Permits that expire by 4 March 2023 and by 4 September 2023 is automatically prolonged until 4 March 2024.

On the basis of Ministerial Decision no. 64419/21.02.2024, concerning the extension of validity of the temporary protection status for displaced persons from Ukraine, the validity of Temporary Protection Residence Permits that expire by 4 March 2023, by 4 September 2023, and by 4 March 2024, is automatically prolonged until 4 March 2025.

On the basis of Ministerial Decision no. 13500/22.01.2025, concerning the extension of validity of the temporary protection status for displaced persons from Ukraine, the validity of Temporary Protection Residence Permits with an initial expiration date of 4 March 2023, of 4 September 2023, of 4 March 2024, and of 4 March 2025, is automatically prolonged for an additional period of one year, that is, until 4 March 2026.

On the basis of Ministerial Decision no. 4507/09.01.2026, concerning the extension of validity of the temporary protection status for displaced persons from Ukraine, the validity of Temporary Protection Residence Permits is automatically prolonged for an additional period of one year, that is, until **4 March 2027**.

As of **17/2/2026**, and **only for travel purposes** temporary protection beneficiaries are informed to reissue their permits in the Ministry of Migration and Asylum Offices by presenting a valid travel ticket. In such a case the **expiration date on the new permit will be 4/3/2027**.

**Diia.pl may be used by Ukrainian temporary protection beneficiaries refugees who stay legally in the territory of Poland based on art. 2.1 of Act on assistance to citizens of Ukraine and who received a National Identification Number (PESEL).**

- Article 10 of the Act on assistance to citizens of Ukraine.

Diia.pl serves as a confirmation of the User's identity and is an evidence equivalent to a document in line with

- Article 8.1 of the Council Directive 2001/55/EC of 20 July 2001 on minimum standards for giving temporary protection in the event of a mass influx of displaced persons and on measures promoting a balance of efforts between Member States in receiving such persons and bearing the consequences thereof

and should be considered a residence permit within the meaning of

- Article 2(g) of the Council Directive 2001/55/EC.

The Diia.pl document can be used by any person who is of legal age.

**5. The document attests the right to reside and work within the territory of Romania for the purpose of secondment.

➤ *permis ICT (intra-corporate transferee permit);*

➤ *permis mobile ICT (intra-corporate transferee mobility permit);*

The temporary residence permit is valid for 1 to 5 years, depending on the purpose for which it is issued. It is an identity document issued by the General Inspectorate for Immigration to foreigners whose right of residence has been granted or extended.

➤ *permis de ședere pe termen lung - UE (long-term EU residence permit)* (in accordance with Council Directive 2003/109/EC of 25 November 2003 concerning the status of third-country nationals who are long-term residents);

➤ *permis de ședere pe termen lung (long-term residence permit)* (issued to foreign nationals who were granted the right to long-term residence as an exception to the general rules);

Long-term residence permits issued to persons who have acquired the right to long-term residence as they previously held an EU Blue Card will state, under the heading ‘Observații’ (comments), that the holder is a ‘Fost posesor de Carte albastră a UE’ (former EU Blue Card holder) and indicate the personal identity number assigned by the General Inspectorate for Immigration.

This document is produced by the Compania Națională Imprimeria Națională S.A. (National Printing Company). The long-term residence permit is an identity document which is issued by the General Inspectorate for Immigration to persons who have acquired the right to long-term residence for a period of 10 years (for foreigners who are family members of Romanian citizens) and to other categories of foreigners for a period of 5 years.

➤ *permis unic (single permit)*

‘Drept de muncă’ (right to work) (and also the indication ‘sezonier’ (seasonal) for seasonal workers) is entered under the heading ‘Observații’ (comments), as is the personal identity number assigned by the General Inspectorate for Immigration. The document is valid for 1 to 5 years and attests the right to reside and work within the territory of Romania.

➤ *permis de ședere temporară (temporary residence permit)*

In the case of documents issued to foreigners granted a form of international protection in Romania, under the heading ‘Observații’ (comments), the type of protection – ‘Refugiat’ (refugee) or ‘Protecție subsidiară’ (subsidiary protection) – will be indicated along with the personal identity number. It is valid for 3 years for those with refugee status and 2 years for those with subsidiary protection status.

**2. PERMIS DE ȘEDERE (residence permit)** – this document is produced by the Compania Națională Imprimeria Națională S.A. (National Printing Company). The permanent residence permit is an identity document which is issued by the General Inspectorate for Immigration to British citizens and their family members who are subject to the Withdrawal Agreement and who acquired the right to permanent residence. It is valid for a period of 10 years.

‘*Art. 50 TUE – ședere permanentă*’ (*Article 50 TEU – permanent residence*) will be entered under the heading ‘Tipul de permis’ (type of permit), and ‘*art. 18 (1) din WA*’ (*Article 18(1) WA*) will be entered along with the personal identity number assigned by the General Inspectorate for Immigration under the heading ‘Observații’ (comments).

**3. PERMIS DE ȘEDERE (residence permit)** – this document is produced by the Compania Națională Imprimeria Națională S.A. (National Printing Company). The temporary residence permit is an identity document issued by the General Inspectorate for Immigration to British citizens and their family members who are subject to the Withdrawal Agreement and who are requesting an extension of their right of temporary residence in Romania. It is valid for a period of 5 years.

‘*Art. 50 TUE – ședere temporară*’ (*Article 50 TEU – temporary residence*) will be entered under the heading ‘Tipul de permis’ (type of permit), and ‘*art. 18 (1) din WA*’ (*Article 18(1) WA*) will be entered along with the personal identity number assigned by the General Inspectorate for Immigration under the heading ‘Observații’ (comments).

**4. CARTE ALBASTRĂ A UE (EU Blue Card)** (in accordance with Directive (EU) 2021/1883 of the European Parliament and of the Council of 20 October 2021 on the conditions of entry and residence of third-country nationals for the purpose of highly qualified employment, and repealing Council Directive 2009/50/EC)

This document is produced by the Compania Națională Imprimeria Națională S.A. (National Printing Company). It is an identity document valid for up to 3 years, issued by the General Inspectorate for Immigration to foreigners whose right to temporary residence has been extended for the purpose of work as a highly-qualified worker, or who have been granted this right without the obligation to obtain a visa. ‘Carte albastră a UE’ (EU Blue Card) will be entered under the heading ‘Tipul de permis’ (type of permit). The document attests the foreigner’s right to reside and work within the territory of Romania as a highly-qualified worker.

In addition to the entry referred to in paragraph (2), the EU Blue Card issued to a foreign national who has been granted international protection in Romania will also bear the indication ‘Protecție internațională acordată de RO la [data]’ (International protection granted by RO on [date]).

In addition to the entry referred to in paragraph (2), the EU Blue Card issued to a foreign national who has been granted international protection by another country will also bear the indication ‘Protecție internațională acordată de [numele statului membru] la [data]’ (International protection granted by [Member State name] on [date]), unless checks carried out by the General Inspectorate for Immigration in the Member State that granted international protection show that this has been withdrawn by final decision.

The EU Blue Card issued to a foreign national on the basis of higher professional skills for occupations other than those belonging to the minor group 133 ‘Information and Communications Technology Services Managers’, and the major subgroup 25 ‘Information and

Communications Technology Professionals’, as set out in the Romanian Classification of Occupations (COR), will bear the indication ‘Excl. gr.min.133/sbgr. maj. 25 COR’ (excluding minor group 133 or major subgroup 25 of COR).

## **OTHER PERMITS ISSUED ACCORDING TO THE UNIFORM FORMAT**

**5. PERMIS PENTRU LUCRĂTOR FRONTALIER (Permit for Frontier workers)** – this identity document is produced by the Compania Națională Imprimeria Națională S.A. (National Printing Company) and issued by the General Inspectorate for Immigration to British citizens who are subject to Article 26 of the Withdrawal Agreement and who do not reside, but are employed in Romania. The document attests the right to entry and work within the national territory. The validity of the permit for frontier workers is equal to the validity of the employment contract, but no more than 5 years. The permit for frontier workers contains, under the heading ‘tipul de permis’ (type of permit), the indication ‘art. 50 TUE – lucrător frontalier’ (Article 50 TEU - Frontier worker), and under the heading ‘Observații’ (comments), ‘art. 26 din WA’ (Article 26 WA).

## **RESIDENCE PERMITS ISSUED IN ACCORDANCE WITH DIRECTIVE 2004/38/EC**

**6. CARTE DE REZIDENȚĂ PERMANENTĂ (permanent residence card)** – this document is issued by the General Inspectorate for Immigration via its regional offices to citizens of the European Union, the European Economic Area, or the Swiss Confederation, and attests the right of residence in Romania and the holder’s identity.

Permanent residence cards are valid for 10 years from the date of issue, except for those issued to people aged up to 14 years, which are valid for 5 years from the date of issue.

The PERMANENT RESIDENCE CARD bears the indication ‘Rezidență permanentă cetățean UE art. 19 DIR 2004/38/CE’ (Permanent residence of an EU citizen under Article 19 of Directive 2004/38/EC).

**7. CARTE DE REZIDENȚĂ (residence card)** – this document is issued by the General Inspectorate for Immigration via its regional offices to third-country nationals who are family members of citizens of the European Union, the European Economic Area, or the Swiss Confederation, and attests the right of residence in Romania for a period of more than 3 months, as well as the holder’s identity.

This residence card is valid for up to 5 years from the date of issue, but not exceeding the period of residence of the European Union citizen to whom the holder is related.

The RESIDENCE CARD bears the indication ‘Rezidență temporară membru de familie UE art. 10 DIR 2004/38/CE’ (Temporary residence of a family member of an EU citizen under Article 10 of Directive 2004/38/EC).

**8. CARTE DE REZIDENȚĂ PERMANENTĂ (permanent residence card)** – this document is issued by the General Inspectorate for Immigration via its regional offices to third-country nationals who are family members of citizens of the European Union, the European Economic Area, or the Swiss Confederation, and attests the right of residence in Romania and the holder’s identity.

Permanent residence cards are valid for 10 years from the date of issue, except for those issued to people aged up to 14 years, which are valid for 5 years from the date of issue.

The PERMANENT RESIDENCE CARD bears the indication ‘Rezidență permanentă membru de familie UE art. 20 DIR 2004/38/CE’ (Permanent residence of a family member of an EU citizen under Article 20 of Directive 2004/38/EC).

## **II. Residence permits which are not in line with the uniform format**

### **DOCUMENTS ISSUED IN ACCORDANCE WITH DIRECTIVE 2004/38/EC**

**1. CERTIFICAT DE ÎNREGISTRARE (Registration Certificate)** - this document, printed on one side on security paper, is issued by the General Inspectorate for Immigration to citizens of Member States of the European Union or the European Economic Area and to citizens of the Swiss Confederation who have a right of residence in Romania for more than 3 months.

All identity cards attest the holder’s right of residence in Romania.

A residence permit issued as a stand-alone document in the form of a card on which the data field “Vrsta dovoljenja / Type of permit” states: “STALNO/PERMANENT” is a permanent residence permit that permits a third-country national to enter the Republic of Slovenia and to reside for an indefinite period of time.

A residence permit issued as a stand-alone document in the form of a card on which the data field “Vrsta dovoljenja / Type of permit” states: “ENOTNO DOVOLJENJE ZA PREBIVANJE IN DELO” is a temporary residence and work permit that entitles a third-country national to enter, reside and work in the Republic of Slovenia.

A residence permit issued as a stand-alone document in the form of a card on which the data field “Vrsta dovoljenja / Type of permit” states: “MODRA KARTA EU” is a temporary residence permit for the purpose of highly qualified employment issued to a third-country national by the Republic of Slovenia for the purpose of highly qualified employment that entitles the holder to enter, reside and work in the Republic of Slovenia.

A residence permit issued as a stand-alone document in the form of a card on which the data field “Vrsta dovoljenja / Type of permit” states: “NAPOTENI DELAVEC” is a single permit for posted workers which entitles a third-country national (who has been posted by his or her employer established outside the Republic of Slovenia to the Republic of Slovenia for a limited period of time in order to provide cross-border services or receive training from a company in the Republic of Slovenia) to enter, reside and work in the Republic of Slovenia as a posted worker.

A residence permit issued as a stand-alone document in the form of a card on which the data field “Vrsta dovoljenja / Type of permit” states: “SEZONSKO DELO” is a single permit for seasonal work of a duration of more than 90 days which entitles a third-country national with permanent residence in a third country to enter, reside and perform seasonal work in the Republic of Slovenia.

A residence permit issued as a stand-alone document in the form of a card on which the data field “Vrsta dovoljenja / Type of permit” states: “ICT” is a single permit for an intra-corporate transferee, which entitles a third-country national who resides and is employed in a third country and has been transferred to an associated company established in the Republic of Slovenia to enter, reside and work in the Republic of Slovenia as an intra-corporate transferee.

A residence permit issued as a stand-alone document in the form of a card on which the data field “Vrsta dovoljenja / Type of permit” states: “MOBILE ICT” is a single permit for an intra-corporate transferee for a long-term transfer, which is a transfer of over 90 days, which entitles a third-country national who is transferred from an associated company established in another EU Member State to an associated company established in the Republic of Slovenia to enter, reside and work in the Republic of Slovenia as an intra-corporate transferee for a period of over 90 days.

A residence permit issued as a stand-alone document in the form of a card on which the data field “Vrsta dovoljenja / Type of permit” states: “PRIPRAVNIK” is a single residence permit for the purpose of a traineeship, which entitles a third-country national to enter, reside and serve a traineeship in the Republic of Slovenia.

A residence permit issued as a stand-alone document in the form of a card on which the data field “Vrsta dovoljenja / Type of permit” states: “ISKALEC ZAPOSLOTITVE” is a single residence permit for the purpose of seeking employment or self-employment, which entitles a third-country national to enter and reside in the Republic of Slovenia for the purpose of seeking employment or self-employment.

A residence permit issued as a stand-alone document in the form of a card on which the data field “Vrsta dovoljenja / Type of permit” states: “VISOKOŠOLSKO IZOBRAŽEVALNO DELO” is a temporary residency permit for work in the higher vocational and higher education sector, which entitles a third-country national to enter and reside in the Republic of Slovenia for the purpose of pedagogical work in the higher vocational and higher education sector.

A residence permit issued as a stand-alone document in the form of a card on which the data field “Vrsta dovoljenja / Type of permit” states: “RAZISKOVALEC” is a temporary residence permit for work in the research sector, which entitles a third-country national to enter and reside in the Republic of Slovenia for the purpose of research work.

A residence permit issued as a stand-alone document in the form of a card on which the data field “Vrsta dovoljenja / Type of permit” states: “RAZISKOVALEC - MOBILNOST” is a temporary residence permit for the purpose of research work on the basis of a long-term transfer, which entitles a third-country national to reside in the Republic of Slovenia and perform research work on the basis of a long-term transfer.

A residence permit issued as a stand-alone document in the form of a card on which the data field “Vrsta dovoljenja / Type of permit” states: “PROSTOVOLJEC”, is a temporary residence permit for the purpose of voluntary work, which entitles a third-country national to enter and reside in the Republic of Slovenia for the purpose of voluntary work and cooperation on voluntary service projects under an EU programme.

A residence permit issued as a stand-alone document in the form of a card on which the data field “Vrsta dovoljenja / Type of permit” states: “DRUŽINSKI ČLAN RAZISKOVALCA” is a temporary residency permit for a family member of a foreign national residing in the Republic of Slovenia on the basis of a temporary residence permit for the purpose of research work issued in the Republic of Slovenia, which entitles a family member of a researcher who is a third-country national to enter and reside in the Republic of Slovenia as the family member of a researcher.

A residence permit issued as a stand-alone document in the form of a card on which the data field “Vrsta dovoljenja / Type of permit” states: “DRUŽINSKI ČLAN RAZISKOVALCA - MOBILNOST” is a temporary residency permit for a family member of a researcher who is the bearer of a temporary residence permit for the purpose of research work on the basis of a long-term transfer, which entitles a family member of a researcher with a temporary residence permit for the purpose of research work on the basis of a long-term transfer who is a third-country national to enter and reside in the Republic of Slovenia as the family member of a researcher.

A residence permit issued as a stand-alone document in the form of a card on which the data field “Vrsta dovoljenja / Type of permit” states: “ŠTUDENT” is a temporary residence permit for the purpose of study, which entitles a third-country national to enter and reside in the Republic of Slovenia for the purpose of study.

A residence permit issued as a stand-alone document in the form of a card on which the data field “Vrsta dovoljenja / Type of permit” states: “ŠTUDENT - MOBILNOST” is a temporary residence permit for the purpose of study, which permits a third-country national to reside and study in the Republic of Slovenia for the duration of the student’s mobility.

A residence permit issued as a stand-alone document in the form of a card on which the data field “Vrsta dovoljenja / Type of permit” states: “ČLEN 50 PEU” is a residence permit issued to nationals of the United Kingdom and their family members on the basis of the Agreement on the Withdrawal of the United Kingdom of Great Britain and Northern Ireland from the European Union and the European Atomic Energy Community (OJ L 29, 31.1.2020, p. 7) (hereinafter: the Withdrawal Agreement), which permits UK nationals and their family members to enter and reside in the Republic of Slovenia.
